TYPES OF PLANNED GIFTS

There are numerous ways to make a planned gift to the Foundation:

Will (Bequest) – The belief that only wealthy people can make a bequest is false. Individuals of modest means who feel they cannot make a gift during their lifetime can do so in their wills. Such donors benefit directly by reducing estate taxes, supporting a program of choice and honoring a loved one without depleting current income. A gift through a will is the most common type of planned gift.

Gifts of Life Insurance – It is common to have a life insurance policy that may no longer be needed for its original purpose. Naming Baptist Health Care Foundation as the owner and beneficiary of the policy provides you with an immediate tax deduction, and the value of the policy will be removed from your estate for probate purposes.

Gifts of Retirement Plans – One of the most beneficial ways for dealing with Individual Retirement Arrangements (IRAs) or other retirement plans is to create a charitable trust in your will to be funded with your IRA. In addition to tax savings, it may also greatly increase the amount received by your beneficiaries.

Gifts That Pay You Income – Some of the best ways to support the Foundation are available through life-income gifts that enable you to make a significant gift to the Foundation while increasing your cash flow. Examples of these types of gifts include Charitable Gift Annuities and Charitable Remainder Trusts.
